<u>Influencing</u> on behalf of the profession and promoting the profession

Solicitor brand campaign highlights

Over the next few months we're doing a lot to promote solicitors, including advertising on digital screens, buses, trams, the metro, at rail stations and in underground carriages, as well as TV, newspaper and online advertising, PR and social media.

At the heart of the campaign is our promotion of you as experts in your field - as honest and honourable, client-focused, approachable and accessible, giving value for money and adding value to society. The Law Society's media profile last week:

Indemnity insurance reforms put forward by the Solicitors Regulation Authority (SRA) last month will damage the small firms the regulator is trying to help, a specialist law firm has warned. The reforms were strongly attacked last week by Law Society vice president Christina Blacklaws, who said she found it "baffling" that the SRA was proposing "further demolition of client protections", on top of plans approved by their board to allow solicitors to practise from unregulated firms. Legal professional bodies have called for the government to halt its court closure programme while technology to replace physical justice is fully tested. The <u>Law Society Gazette</u> quoted me saying: "If current proposals are implemented unchanged, people will lose access to their local courts and potentially have to travel hundreds of miles to alternative sites."

Richard Atkinson, co-chair of the criminal law committee, appeared on BBC Breakfast & BBC News 24 last Friday to discuss an increase in the number of suspected criminals, including those suspected of violent crimes, being released without bail conditions as a result of changes implemented last year.

Senior lawyers have warned that the rapid expansion of "online courts" could result in people being cheated of justice as the government launches a ground-breaking pilot scheme today. Ministers are testing a system designed "to make it quicker and easier for people to claim money owed, resolve disputes out of court and access mediation". Under the scheme, operated by HM Courts & Tribunals Service, those involved in a dispute with a value up to £10,000 will be able to make their claims online instead of filling out paper forms.

Using tech where appropriate will hopefully free up resources to aid those who are unable to make use of such tools."

A letter from the Bar Council and the Law Society — the bodies that represent barristers and solicitors in England and Wales — as well the International Bar Association called on the Turkish government to lift its state of emergency. Consultation responses and parliamentary activity, influencing on behalf of the profession:

Court closures

We submitted responses to a number of consultations on court closures. One consultation related to the overall approach to the <u>closure</u> programme, and there were five other consultations proposing specific court closures. We have argued that the closure programme should be suspended until the alternative options being tested through the HMCTS reform programme have been developed and proved to work.

Brexit – what members can do to help

29 March marked one year on from the triggering of Article 50 and we have put together a short summary of the work we have been doing on Brexit – <u>read about our work here</u>. Members can support our Brexit activity by:

 Writing to their MP – we have launched a <u>write to your MP action</u>. Using our online system, you can write to your MP to urge the government to negotiate and secure the continued rights of lawyers in EU member states after Brexit. Submitting evidence to the APPG on Legal and Constitutional Affairs inquiry
on Brexit on the provision of legal services – we act as the secretariat for the
APPG on Legal and Constitutional Affairs, which has launched an inquiry into the
effect of Brexit on the provision of legal services. As part of that inquiry, we have
published a call for written evidence which is now open and we are encouraging
members to contribute. We will be holding three oral sessions in Parliament over the
coming months, before making a final report with recommendations to government.

Criminal Law

Two criminal consultation papers were received this week: a Law Commission Sentencing Code on child and young person sentencing provisions and a Sentencing Council draft guideline on arson and criminal damage.

AML

The Financial Conduct Authority (FCA) has contacted us about a supervisory visit to the Law Society by the Office for Professional Body AML Supervision (OPBAS). The visit will take place at the end of May.

The Treasury Select Committee has announced an inquiry into economic crime, with a deadline for submission of written evidence of 8 May.

We have written to the Law Commission about its review of the consent regime provisions in the Proceeds of Crime Act 2002 and the Terrorism Act 2000.

Women and Equalities Committee

In <u>this</u> written submission to the Women and Equalities Committee on its inquiry into sexual harassment in the workplace, we discuss the law relating to harassment functions, and make suggestions on possible improvements.

The chair of the Employment Law Committee, Max Winthrop, gave oral evidence on this to the Committee on 28 March.

Last week we were mentioned by MPs in four parliamentary debates on:

- Legal aid and the Birmingham pub bombings Richard Burden MP (Lab) referenced our call to widen the scope of funding for representation.
- Court closures and reform Tan Dheshi MP (Lab) raised our concerns on the impact
 of court closures on legal aid firms and on police resources and other organisations
 that use the courts.
- Promotion of legal services after Brexit we were mentioned in the debate three times by Justice Committee Chair Bob Neill MP and by Justice Minister Lucy Frazer QC MP.
- Brexit implications for the justice system in a debate on the Justice Committee's report (and Government's response) on the implications of Brexit for the justice system, our recent report on a Canadian style trade model for Brexit was mentioned and quoted from by Justice Select Committee member Bambos Charalambous MP.

Our influencing work internationally:

On 3-4 April, we participated to the International Law Conference in Cambridge.

On 5 April, Day of the Lawyer in Turkey, we sent an open letter to Turkish authorities highlighting human rights violations against lawyers in Turkey. The letter was sent jointly by 5 organisations: The Law Society, the Bar Human Rights Committee, the IBA Human Rights Institute, the Union Internationale des Avocats and the Bar Council (see Media above).

Handbook for Local Law Societies

The planning and writing of the handbook to help support the invaluable work that local law societies undertake is well underway and is on schedule for its launch at this year's Presidents and Secretaries Conference on 11 and 12 May. The handbook is intended as a working resource, to help Local Law Societies manage and run their affairs more efficiently, get their governance right, give societies the tools to lobby and campaign on behalf of the profession and improve their communications with their members.
