# SUSSEX LAW SOCIETY REPORT OF THE GENERAL COMMITTEE FOR 2016/17

#### PRESIDENT'S REVIEW OF THE YEAR

I have enjoyed my year as President, but look forward to handing the mantle to Emma Weir. The transition from me as a corporate lawyer to Emma as a private client lawyer, seems entirely appropriate for a Society intended to represent the local legal community.

My thanks to the Sussex Law Society Committee and to our COO, Jeanette Lacy Scott, for their energy and good humoured support this year, which has been invaluable.

I have enjoyed meeting lawyers from across the region this year and have been fortunate to attend a number of other local law society annual dinners, which has allowed me to see and talk to partners from a variety of practices in Sussex and Kent. Whilst it is clear that our profession faces a number of challenges, both economic and regulatory, I have been struck by the strength, resilience and quality of the legal community in Sussex.

In my newsletter comments this year, I have reflected on how partner skills of client care can be transitioned into contemporary legal practice, and how young lawyers can learn from the skills honed by those toward the later part of their careers. Twenty or more years ago, individual solicitors had broader practices and many have followed their clients through changes in their personal and professional lives; these days lawyers specialise on qualification.

While there are themes which remain consistent over the years, our profession faces significant challenge. New entrants to the market, including some large commercial operators, means a risk that our profession might appear old fashioned and out of date. Each of us need to work out how to effectively promote the professional values and experience we bring to clients, and must not wait for someone else to do that work for us. Law practices have always been entrepreneurial businesses at their heart, and now is a time we need to focus on how we each approach and address our chosen markets.

Merger and integration continues apace, but new smaller and more specialist firms are also emerging. Size is certainly not the key to success, but being the right size for the business model you have chosen and the market you address is essential.

So, given these challenges how can local law societies help?

Above all we can provide an opportunity for local solicitors and those joining the profession to mix together, network and learn from one another. The social and networking side of the Sussex Law Society has always been strong and we will work hard to continue that, along with our high quality technical training programmes. I am delighted that the Junior Lawyers Division is reborn this year and, with a new committee ,will be arranging events.

Whilst encouraging networking within law society members, the Society can also help forge links with other professionals, which I have been keen to progress this year. I was particularly grateful for the support and sponsorship we received this year at our Annual Charity Dinner at the Grand in Brighton from local businesses, Kreston Reeves, EMC and Barclays. The annual dinner and dance remains at the centre of our years activity and was well supported this year. It offers an opportunity for local firms to promote themselves and to give a well earned night out to key staff.

#### HON. TREASURER'S REPORT

The accounts for the year ending 31st August 2016 are included in this report. As with previous years, now that the AGM is held on a date between 1 September and 30 November, the accounts included in the Annual Report are a year behind. The Chartered Accountants who advise the Society merged during 2016. The Committee reviewed their position and new accountants have been administered. It is hoped that in future years they may be able to produce accounts on a current year basis.

# Accounts to 31 August 2016

The accounts show a loss of £2804 compared to last year's profit of £4202. The increase in expenditure was largely the cost of our new website (£4024). Our income showed a slight fall in membership subscriptions (£608) and a smaller surplus on courses run by the society (a reduction of £2611). Despite this, the balance sheet shows a Capital account balance of £18472, which although down on last year is still better than in 2014.

### The year to 31 Aug 2016

The committee remains of the firm view that the Society offers our members good value for money and worthwhile membership benefits. This is a considerable achievement and we are grateful to all of our sponsors who, in various ways, support our Annual Dinner, website, newsletter and individual social events. AON were our main sponsor during this year and others included PSG, STL, Searches UK, Indexpi, Conveyancing Data Services and Wesleyan. Sadly, STL decided last year not to continue sponsoring our property courses after years of support for which we thank them. They continue to sponsor the website. PSG have stepped in as our property courses' sponsor and that is working very well. Wesleyan sponsored many of our other courses and, again, they are another great organization to work with. The new website has attracted sponsorship and it is hoped, as we attract more traffic, we will encourage more sponsors.

The support of the members of the Society is apparent in the accounts to 31 August 2016. The continuing support of members of the Society's courses and social programmes will further strengthen the Society.

#### **COUNCIL MEMBER'S REPORT**

This last twelve months has been dominated by the departure of our Chief Executive and the drive to implement changes to The Law Society's governance and management structure, allowing it to coordinate and deliver the development of strategy and policy in a faster, far less complicated way. This process is expected to create an environment in which Council can have confidence in delegating the running of the business to the (Main) "Board", with support from Policy and Operations, and most importantly to the Executive. This has not necessarily been the case recently. Policy making and strategic direction have been confused and ineffective. A clear and consistent structure is overdue and it must set the pace.

The AGM of 6th July 2017 marked a particularly significant change of the guard at Council, with thirteen members stepping down, to be replaced by fresh and energetic new blood. This included two new Seats for the Junior Lawyers Division, the local Chapter of which is resurgent, being encouraged and features on every Agenda of the Sussex Law Society general committee meetings. A summary of Council's discussions the day before the AGM can be found in The Gazette of 17th July.

A key debate has continued to be over the SRA's push for changes to the Handbook. The Law Society has responded very strongly, arguing that the SRA is ignoring its primary role of regulating for the protection of consumers, by opening the door to some Solicitors to work in unregulated entities, thereby sweeping away long-

standing rules on conflict of interest and PII. The question over the extent of information about legal services being offered and its usefulness and relevance to Clients, also needs to be clarified. There is now however a feeling of reconciliation and more general corroboration with the SRA. The problem has been the perception of the degree of "oversight" (undefined) which TLS should retain over the SRA without being seen to be interfering with its regulatory functions. The Legal Services Board to which the SRA lodged its complaint has a listening ear but little political will to become involved!

Lessons have been learned from the embarrassing CAT judgement in "Socrates" where I can assure you that The Law Society acted in good faith as it continues to maintain and promote CQS. By way of reminder, this was launched in 2010 following Lenders' concerns over the quality of conveyancing services and threatening draconian panel culls. It was not intended to be a profit making venture but as it grew in popularity, ongoing training requirements were necessary. By 2015 it was deemed that The Law Society had gained a dominant, anti-competitive position. Settlement was offered but the Claimant persisted.

"Exit Strategy" forums are being oversubscribed and therefore repeated. Look out for these. Sign up to "My Law Society" (straightforwardly done with your SRA details to hand.). I am trying to get roadshows on our patch. The SRA monthly bulletins are also useful and informative, if only to judge the different stances yourself! For that of The Law Society on the future of the SIF,do refer to The Gazette 4th September 2017 "Solicitors Indemnity Fund-20120 Vision".

One very interesting Consultation coming up is the SDT's proposed review of its Rules and within it, the standard of proof it uses. Please consider the Law Society's position (that the criminal standard be maintained) as it invites the views of members. The SRA offers the balance of probability test. The LSB will ultimately need to approve any Rule changes.

### REPORT OF THE CONTINUING EDUCATION COMMITTEE

So far, despite the new SRA regulations on continuing professional development for solicitors which came into effect from 1 November 2016, numbers attending Sussex Law Society courses have remained stable. The fear was that, because solicitors no longer had to attend accredited courses for a percentage of their required CPD hours, numbers would drop dramatically. Of course it is still early days, but solicitors still need to continuously identify their training needs and address and record their learning and development activities and we believe that our courses will continue to be an invaluable part of this process for many members. In fact, many I have spoken to have said that attending a course is still one of the best ways of accessing training and provides an invaluable opportunity for interaction with the speaker (the 'expert') and other participants as well as networking opportunities with fellow professionals. A forum to share common experiences is also a benefit to many.

In the training year 1st September, 2016 to 31st August, 2017 we ran 20 courses and the average attendance was 20 participants at each. In order to break even we need at least 15 people on every course we run (on some courses where the speaker's fee is very high we need more). It is a difficult balance always trying to keep course fees low for members but not compromising on speaker and venue quality. Although the Society does not solely depend on the income from profit from courses, it does play a large part in funding our operation and so obviously we cannot run courses which we have to subsidise. Unfortunately, this means that sometimes very interesting courses on topics relating to some of the smaller practice areas which we have organised have had to be cancelled due to insufficient numbers. We continue to look at ways in which we can attract higher numbers and plan to make much more use of social media to this end in the forthcoming year.

We are proud of our local, high quality, extremely good value courses which continue to receive excellent feedback from those who attend. Here are just a few comments from a recent course "As always an excellent training session both timely and all very relevant", "Fantastic speaker", "Very informative". So please continue to support our continuing education programme and visit the website <a href="http://www.sussex-law.co.uk/courses/">http://www.sussex-law.co.uk/courses/</a> regularly to see what is coming up (as new courses are added throughout the year) and encourage others in your firm/organisation to do so as well. If what you are looking for isn't there – then tell us and we can see what we can do.

We are still trying to persuade the Law Society to bring some of the events they are planning to initiate/regenerate local groups of lawyers, e.g. in house lawyers, small firms and young lawyers to the Sussex area and we are also looking at setting up some informal 'meet' ups for solicitors in specific practice areas.

#### 8. President's Address

Mr Grant introduced himself as a corporate lawyer and partner in DMH Stallard LLP, working from their Gatwick office. He qualified in 1989, starting his career at Fitzhugh Gates and had subsequently worked in private practice in Brighton, Kent and in the north of Sussex.

He said that during his year he was keen to increase membership and involvement from solicitors living and working in the north of the constituency as, over the years, the balance had changed and there were now a significant number of firms in the north of Sussex. He also felt that the Society should be looking at more ways of trying to help younger members of the profession develop and providing more support to people who wanted to get into the profession.

Mr Grant reflected on the uncertain times ahead, particularly post Brexit, and said that many law firms were facing new difficulties and challenges. He felt that the Society had an important role in bringing members together to help each other and also, by encouraging more networking with other local professions, to open up more business opportunities.

Mr Grant concluded by saying that the General Committee would be discussing the plan for the year at their annual strategy meeting in November where some plans to action the above would be discussed.

After the meeting some members went on to a flight on the new i360 in Brighton followed by dinner.
