COUNCIL MEMBER'S REPORT

On 26th and 27th February the Law Society hosted a two day Special Planning Event at Chancery Lane. This is an annual event to which all Council members are invited and which is well attended.

The purpose is either to set or review the Law Society Corporate Strategy. This is a three year Strategy and the current 2022/25 Strategy can be found at <u>Corporate strategy 2022/2025 | The Law Society</u> The Law Society seeks transparency and the full Corporate Strategy, Business plan and quarterly reports are available on the website.

As we are now in 2025 the event was partly to review delivery by The Law Society against the objectives set in 2022 and partly to assist the Society set the 2025/28 Strategy which will run from October 2025.

What has this got to do with me? (A Sussex Law Society member might ask).

Well, nothing if you don't want it to!

However, The Law Society (TLS) is your professional body. You pay for it. You might think it is actually quite good value - it represents less than $1/3^{rd}$ of your Practising Certificate fee, less than £100/member. That compares favourably with other professional representative organisations.

It is there to support and represent you and the purpose of the Corporate Strategy is to identify what issues TLS should be focusing on and where its resources should be directed.

TLS income is approximately £50 million, of which approximately £37 million comes in PC fees and a not unimpressive £13 million from commercial activities of the Society. Operating costs are in the region of £48 million. The purpose of the SPE event and the Corporate Strategy is to establish what should be the priorities when allocating these resources.

2022/25 - objectives

- promote the value of the profession and provide a compelling member offer
- protect the justice system and make sure it applies to everyone equally
- maximise our potential by growing our commercial reach, by being efficient and sustainable
- be an employer of choice for people who want to make a difference

For 2025/28, the key objectives are being worked out but it might be helpful for members to understand some of the key projects in the coming years:

Resources on AI and technology to support members Delivering the new member facing D&I strategy Deliver a Solicitor brand campaign New content and resources for in house, juniors and large firms More regional in person engagement Increased resource for campaigns

A key component of the 2025/28 plan is going to be a "Get Involved" Strategy. This is aimed at increasing engagement from the wider profession in the work of the Law Society. So, for example, if you have a particular interest or experience in how AI might help Law Firms then you will be able to register your interest and may then be contact with a view to assisting TLS formulate policy, give guidance or become involved in training. TLS is very keen to engage with members.

Once the 2025/28 has been fully worked out then it will be on TLS website.

HMPPS BAIL INFORMATION SERVICE

The HMPPS Bail Information Service (BIS) is being rolled out nationally, with recruitment underway to support the delivery of this service both at first hearings (probation court staff to support) and second or subsequent hearings (to be supported by prison-based staff). Bail information reports (BIR) provide relevant, objective, and factual information to the court to enable it to make fully informed decisions about bail or custodial remand. Bail Information Officers do not advocate for or against bail but gather information to assist the court decision. To read more, see <u>here</u>.

CONSUMER PROTECTION?

Had enough of currently widespread AML spot checks on smaller firms, increasingly disproportionate fines, fraud prevention, Axiom Ince culpability etc and instead fancy an existentialist discourse amongst property solicitors in particular? Begin by considering the SRA "warning" twelve months ago when the state of the Compensation Fund was brought to our attention and then move on to last May when the SRA (for whatever sinister reason) quickly announced a proposed review of legal services it regulates under the above banner. Launched in November, recently closed to further responses and still available with supporting evidence on which it relies upon, its proposals are widespread, interesting to read but unpleasant and potentially life-changing to sole practitioners and smaller firms. Those particularly involved in the conveyancing process will have been alarmed by the declared intent to remove a Solicitors Client Account to a (French style?) third party managed Account. Albeit only part of a wider important and topical discussion with regard to who and how Client monies should be held, how the Compensation Fund can continue to exist in its present form, splitting compliance and ownership Rules, and the revert to mandatory annual Accountant's Report, this particularly emotive issue has generated vociferous objections to the echo of crying "unjustified" "unpracticable", "safeguards ?" from The Law Society , the five largest "joint" local law societies and various property lawyer groups in England and Wales. This is going to rumble on and on, hopefully in a lessons-learned constructive way, with the Legal Services Board brave enough to take a stand and without the now boring continuing spat between TLS and SRA.
