PRESIDENT'S REPORT

Welcome to June's edition of the newsletter, which as I type looks like it should be received by you in blazing sunshine. We can but hope! Whether or not the proposed easing of lockdown happens on 21st June remains to be seen, I do feel like there is increasing optimism throughout the profession and society in general. I have certainly noticed that more networking events are starting to take place in person rather than on-line, which feels like another step toward normality, as I for one am starting to suffer a little bit of "zoom fatigue"!

Having said that, on 27th May I attended an on-line meeting of most of England and Wales' local law societies hosted by I. Stephanie Boyce and Lubna Shuja. Before the meeting we had been asked to prepare a 1 minute speech on the most important issue to our members. Frankly I could have taken up the whole 90 minutes, but I chose the topic that has come up most when discussing professional woes with other Managing Partners – the hardening of the PI insurance market and the proposed withdrawal of the SIF. Having received statistics of 30% premium increases and restricting criteria such as no more than 20% conveyancing turnover, it felt like a fundamental issue that would affect every one of our member firms. The content of my speech was echoed throughout those given many other local law societies.

As you can imagine, many other topics were raised, including lawyers' mental health, access to justice, the over-burdened and under-funded criminal justice system, lawyer comparison websites, training and development of junior lawyers, and the proposed expansion of non-reserved legal activities. The cynics amongst you may think we were merely being paid lip service, but I am hopeful that our new President took everything on board; and although she doesn't have a magic wand, even just listening what troubles local law societies will start to bring about some change.

So, ever the optimist, I leave you with that and wish you a happy, and sunny, June.

ALL CHANGE FOR LEASEHOLD DWELLINGS

On 11 May 2021, the Government in the Queen's Speech announced a whole raft of legislation in relation to leasehold dwellings in England. One Bill, the Leasehold Reform (Ground Rent) Bill 2021 is already in front of parliament. Further legislation is promised relating to leasehold extensions and also the abolition of S.21 shorthold notices and no fault eviction of short term tenants.

Furthermore, there are numerous developments in relation to fire safety after Grenfell. The EWS (External Wall Systems) 1 certificates continue to cause major problems, and RICS updated guidance produced in March 2021 has muddied the waters. In addition, the much awaited Fire Safety Act 2021 received the Royal Assent on 29 April 2021 and changes the nature of fire safety risk assessments. The Government has also announced that it is to proceed with a Building Safety Bill 2021 in this Parliamentary year. These changes amount to the greatest overhaul of residential leases in a generation.

Richard Snape is a leading authority and speaker on conveyancing matters and [In this article](#) discusses the changes proposed during the Queen's Speech on ground rents and other planned reforms.

COUNCIL MEMBER'S REPORT

It's June and we are all looking forward to the end of the roadmap and fingers crossed that circumstances permit the ending of the Covid restrictions. However, it also means that there is less than three months to go before the Solicitors Indemnity Fund ('SIF') comes to an end. Resulting in there no longer being run-off cover for firms who ceased, without a successor, since 1st September 2000. Those affected who will now need post-six-year run-off cover are expected to find it on the open market.

I cannot put the position better than what has been said by Nick Gurney-Champion, chair of the Law Society's Professional Indemnity Insurance Committee. Nick's statement to Council, on 19th May, can be found [here](#).

What I can say is that the Law Society is working hard to (i) persuade the SRA to again extend the SIF closure date, (ii) find a market solution to fill the gap if/when the SIF does close, and (iii) push the message out to find all of those retired members of the Society who will be affected. It may come as no surprise to some that the Law Society's and the SRA's records are incomplete.

So if you are, or if you know, of a solicitor who retired before 2000, please forward this newsletter and I ask that person to contact [me](#), [this society](#), or the Law Society for more information.

I would also encourage you to write to both the SRA and the LSB to express your concerns regarding the closure of SIF, particularly from the client protection point of view. Whilst it is, of course, important for us solicitors, clients will also be badly impacted by SIF's closure.

ISSUES WITH THE COURT OF PROTECTION UPDATE

Since the last Newsletter we have received a very helpful reply from the Delivery Manager at the COP at First Avenue House who has looked into the issues we raised following feedback from members, specifically about communications with the COP. Her responses are below *in italics*:

Difficulties in corresponding with COP on applications when a judge has requested amendments or resubmission

"I am sorry you feel the responses you receive from us on next steps on these applications are not always helpful and are sometimes unclear. I would assume that the directions given by a Judge, which are communicated to you by letter or by an order, are clear and self-explanatory. The expectation is that professionals in the relevant area of law would know what is required when filing an application and what the next steps are.

If the judges' direction is not clear, you can make an appropriate application, which will be referred to the judge who gave the initial directions. If this is a concern you have had on a few applications, it would be useful to have the case numbers and I am happy to refer them to Her Honour Judge Hilder to review. If there has been an error in the draft you have received, court staff are responsible for making the necessary amendments. Again, if you can provide me with further details on the cases, I will look into it."

Difficulties in contacting us by phone

"I acknowledge the difficulties our users are facing, in trying to contact us by phone. Our contact centre is based in First Avenue House and with no call diversion facility, staff have to be in the office to attend the phones. For most of the last year, we have been working on 50% capacity and this has led to significant backlogs in most areas of our work. The call drop is an issue we are aware of and have raised it with the service provider. I appreciate this is frustrating, for which I am sorry. We are looking into resolving the issue and hope to rectify this in the coming months."

Letters are ignored and no continuity of service with emails

"It is disappointing to hear that you have not been receiving a satisfactory response to your letters and emails. I have shared your feedback with the managers and hope that you will see an improvement in the coming months. If there are any specific cases that you would like to raise with me, I am happy to review."

"INDEPENDENT" ASSESSMENT OF THE SRA'S QUALITY OF ENFORCEMENT

Practitioners will have noticed increasing concerns regarding the SRA's current policy, including wasted costs, disproportionate ethnic minority subjects of action, and decisions to pursue junior lawyers who had reported suffering from mental illness. Amongst the changes outlined in the 21/22 business plan, itself part of the ongoing three-year strategy to maintain high standards, is the proposal to set up a new independent entity. Whilst its arms-length remit has not been finalised, the remaining business plan focuses on discrimination, diversity and inclusion, the adoption of technology and innovation in the profession, and to anticipate and respond to change. The SRA's plan to reduce the maximum award from the Compensation Fund from £2m to £500,000 was strongly opposed by the Law Society and the SRA has now backed down. We have been reporting on the ongoing transparency issues where the SRA says it will continue to do observe the recommendations of the Competition and Market Authority to provide quality indicators for consumers to know more about their legal provider, competency requirements and to enhance the existing solicitors register. The continuing commitment to oversee the SQE is becoming a priority for this year.

UK Community Foundations (UKCF) is working in partnership with the Charity Commission on the [Revitalising Trusts Programme](#), set up to ensure funds from inactive or dormant charitable trusts are 'unlocked' and spent on good causes across the UK.

Even though many of these trusts are very small, collectively the funds hold a significant amount which could make a huge difference to local communities, if revitalised. The programme has been running since 2018 and, in that time, it has revitalised over £50million of inactive funds. This money has been distributed to UKCF, local community foundations and other charities, who have spent it
