#### OPEN CONSULTATION ON ALIGNING THE FEES FOR GRANTS OF PROBATE TO COST RECOVERY

This MOJ consultation proposes to align the fees for professional and non-professional applicants of probate into a single fee of £273. This fee reflects the costs to Her Majesty's Courts and Tribunals Service (HMCTS) of providing the service and would not generate a profit for the government. The MOJ have stated the objectives of this proposal as follows:

- to remove the unjustified discrepancy between professional and non-professional applicants for probate. This would bring the fee structure into alignment with HM Treasury's Managing Public Money, where all users should pay the same fee for the same service.
- to ensure that the fee recovers the cost to Her Majesty's Courts and Tribunals Service (HMCTS) of delivering the service.
- to protect access to justice by ensuring that courts and tribunals are adequately resourced, while reducing the overall taxpayer subsidy for HMCTS.

The consultation closes at 11.59 pm on 23<sup>rd</sup> September, 2021. You can find the consultation document <u>here</u>.

# LATEST FROM THE COMPLIANCE & REGULATION COMMITTEE

#### **SQE Assessments**

There is no monthly SRA bulletin this August and both candidates and providers continue to be reminded that the first SQE 1 is in November. Registration and booking are now open. To stay ahead of the game, particularly if reasonable adjustments are requested, candidates are urged to do so as

soon as they can. If applicable, providers can then anticipate any agreed adjustments, such as undertaking mock assessments. There is more information on the SRA website <a href="https://example.com/here">here</a>.

Second round of monthly SRA audit of late submissions of AML risk assessment policy.

The first round disclosed the names of the six firms falling foul of the implementation of non compliance and the fines being administered. Whilst these were in the range of £800 with everyone then satisfying the necessary criteria, the latest monthly list of culprits (originally randomly approached and then beyond the 12 month remedial date) has alarmingly doubled. In one instance it was ramped up to the more serious "rebuke" status.

# **'EXERCISING BREAK CLAUSES: THE PITFALLS' WEBINAR**

The exercise of break clauses is highly topical in the current climate and landlords will be anxious to see that the tenant cannot successfully break the lease, not least because of business rates liability on empty properties.
