## SIF FACT SHEET

On 23 November 2021, the Solicitors Regulation Authority (SRA) launched a consultation on the future of the Solicitors Indemnity Fund (SIF) and post six-year run-off cover (PSYROC). The Law Society have produced a useful factsheet to assist understanding of 1) How we have arrived at the current situation. 2) The content of the consultation. 3) Issues around the SRA's proposals about SIF.

The Law Society have not set out their proposed position in the fact sheet, but have said that they will circulate an outline argument in January, to aid local law societies in preparing submissions.

The prospective closure of SIF and the unavailability of alternative PSYROC options threaten an unacceptable transfer of risk from solicitors to clients. This could seriously undermine public confidence in the solicitors' profession, which means that the outcome is of importance to all Law Society members. The fact sheet can be found [here](#).

[Solicitors Indemnity Fund \(SIF\): background and consultation | The Law Society](#) - On 23 November 2021, the Solicitors Regulation Authority (SRA) launched a consultation on the future of the Solicitors Indemnity Fund (SIF) and post six-year run-off cover (PSYROC).

[Cut family court backlog by restoring Legal Aid for early advice | The Law Society](#) - Family court statistics for July to September 2021 published on 16 December show there were an estimated 63,084 new family cases.

“Our concerns about the significant backlogs in the family court pre-date the pandemic. However, the existing problems have been compounded in the last 18 months,” said Law Society of England and Wales president I. Stephanie Boyce.

[Long-awaited pay rise proposed for criminal legal aid lawyers | The Law Society](#) - We’ve welcomed proposals to increase pay for criminal legal aid solicitors, following substantial campaigning from the Law Society on behalf of our members.

On 15 December 2021, a report recommending increased remuneration rates for criminal legal aid solicitors was published as part of an independent review chaired by Sir Christopher Bellamy.

[Proposed criminal legal aid funding boost welcome after 25-year wait | The Law Society](#) - A recommended funding boost for criminal defence solicitors was today welcomed by the Law Society of England and Wales, which has spent years campaigning for additional resources for the beleaguered justice system. But despite that welcome, concerns remain as to whether the cash injection will be sufficient to make the criminal defence sector truly sustainable. The report of the Independent Review of Criminal Legal Aid, chaired by Sir Christopher Bellamy, has been published along with government confirming it will issue its full response and consultation by the end of March 2022.

[Remote hearings invaluable but concerns remain | The Law Society](#) - A report on the use of remote hearings during the coronavirus (COVID-19) pandemic was published by HM Courts and Tribunals Service (HMCTS) on Friday 10 December.

“Remote hearings have been an invaluable tool in keeping the justice system operating during the pandemic,” said Law Society of England and Wales president I. Stephanie Boyce. “However, the evaluation of their use by HMCTS reflects concerns we have raised that in some scenarios they are unsuitable and can have a serious impact on access to justice and may not be suitable for vulnerable people. Our own research found that only 16% of solicitors felt vulnerable clients were able to

participate effectively in remote hearings, and only 45% were confident that non-vulnerable clients could do so.”

[New guide issued to stop property title fraud | Today's Conveyancer \(todaysconveyancer.co.uk\)](#) - The Fraud Advisory Panel, HM Land Registry (HMLR) and the Law Society of England and Wales have issued a guide to help homeowners avoid property title fraud. The guide, aimed at homeowners and conveyancing clients, details how and why property fraud occurs, and sets out the following precautions that can be taken to keep title deeds secure.

#### LEGAL SERVICES BOARD

The oversight regulator has just published its annual assessment of the performance of each of the eight providers of the different types of legal services in England and Wales. Each has a statutory obligation to be assessed under the same 27 outcomes across five standards: regulatory approach, authorisation, supervision, enforcement, and well-led governance and leadership. This year the boards of CILEx, Costs Lawyers and the SRA have met all the requisite outcomes. Helpful interim reviews encourage those in need to improve ( their regulatory approach and leadership in particular) before next year’s assessment. As well as seeking to improve overall performance, the area of focus this year will be the issue of the transparency of decision making . The SRA will be particularly mindful of this when now implementing its annual action plan and seeking to apply for any changes to its arrangements.
