CQS COMPLIANCE FOR CONVEYANCING SUPPORT STAFF

Following the CQS onsite assessment pilot of late 2019/early 2020 and the subsequent interruption caused by the Covid pandemic, the formal commencement of the new CQS assessment regime is

imminent once Covid allows, likely in Spring 2022. How confident are you that your conveyancing support staff will be able to demonstrate adequate knowledge of the CQS Core Practice Management Standard when your firm is selected for its CQS onsite assessment? The CPMS requires relevant personnel in the conveyancing department to ensure they have knowledge of the CPMS and how the firm complies.

Tracy Thompson, Lead CQS Assessor, is delivering a live webinar for us from 10am – 12pm on Tuesday, 8th March which is designed for all conveyancing support staff and fee earners who need to understand the content of the standard in preparation for the assessment. FRC UPDATES FROM HHJ FARQUHAR

<u>12th January 2022</u> – Please find links to the newly approved <u>Efficiency Statement for hearings in the FRC below High Court level</u>, together with the <u>FRC notice</u> and the approved templates (<u>Template ES1</u> and <u>Template ES2</u>). These have now been approved by the President and take effect immediately.

I would urge everyone to read these documents in full but I would point out the following highlights:

- 1. The parties are to file agreed, or separate market appraisal value of the former matrimonial home, property details and mortgage capacity 14 days before First Appointment para 10 ES
- 2. Questionnaires are to be no more than 4 pages para 10 (c)
- 3. The Applicant must file a composite case summary and composite schedule of assets & income on the approved templates. Para 11 ES
- 4. These documents must be updated for the FDR and there must be a composite chronology as well para 13 ES
- 5. A timetable for the final hearing should be prepared at the FDR para 19 and the documents are to be updated once more.
- 6. The content of a s.25 statement is set out in para 22 and best practice states it should be limited to 15 pages.
- 7. Court bundles are limited to 350 pages para 23
- 8. Position statements are to be no longer than 6 pages at First Appointment, 8 pages for interim hearing, 12 pages for FDR and 15 for final hearing.
- 9. The order should be drawn (if at least one of the parties is represented) before leaving Court para 33
- 10. The date for the next hearing is to be set before the parties leave Court para 34
- 11. The templates for the schedule of assets and case summaries. These are to be 'composite' documents meaning that they do not need to be agreed but only one is filed and the differences can be noted easily.

The aim of the changes is to reduce the amount of documentation and ensure that it is more focussed, and consequently improve efficiency. I accept that it will involve more work to create 'composite' documents and that there must be greater liaison between the parties to achieve this. This may well be 'challenging' even between fellow lawyers and the level of that challenge could increase significantly when there is a litigant in person involved. I hope that, in due course, these changes will improve the running of the FRC. Many of you may have misgivings about some of the details involved, but it is difficult to argue that there is not a need for change

I am well aware of the issues of ensuring that documents that are produced actually get before the judge and I am trying to take steps to improve the situation. In the meantime, I would urge that you make sure that all documents are uploaded to the digital system (for those cases on the system) and

that if you know the name of the judge dealing with your case that you E-mail the most recent documents (position statements, schedules etc) to them directly.

7th February 2022 - I am delighted to say that we finally have a new form D81, which will hopefully mean that all the relevant information that needs to be provided for the Court to consider the application will be provided. I appreciate that more detail is required in the new form but this should reduce the number of occasions on which a Judge will need to ask the parties for further information to consider the order.

Please commence using this form immediately and, as stated in the attached document, they are to be used exclusively from 18th February 2022.
