FRC UPDATE FROM HHJ FARQUHAR

Dear All

I hope that all is well in the FRC world – or as well as it can be in present circumstances.

I am well aware that there are many problems we face and I am not going to set them all out here, but we are doing all that we can to deal with them all. I know that we all have far too many e-mails which are too long so I will keep this as brief as possible.

1. The contested online portal is to become compulsory at some point in early 2023 – please see <u>this letter</u> for details. Can I add one detail that is not widely known. The case numbers for the online portal are 16-digit numbers in the form 1111-2222-3333-4444. The same format is used for new divorces. However, the divorce number is NOT the same as the FRC number!! This has been raised as an issue and we have been informed that there are IT reasons why this must be the case. Please bear this in mind when using the portal – we will all slip into error on this one from time to time, but no doubt we will get used to it.

- 2. First Appointments. In general, these remain remote hearings. Do practitioners believe this is achieving the best outcomes? Would more be achieved if they were all attended hearings? Please let me know if there are strong views either way. I know which system is easier for practitioners, but the question is in relation to outcomes of hearings.
- 3. Complex cases these should all remain in the Kent, Surrey & Sussex area unless they are allocated to a High Court Judge the days of transferring these to the CFC have now gone.
- 4. Judicial Resources. I am sure that many of you have been faced with the 'hearing vacated due to lack of judge' e-mail. I know how incredibly frustrating this is but there is simply no 'magic Judge tree'. I am doing all I can to persuade judges from other areas to agree to sit in our beautiful part of the world, but there is a limit and it just passes the problem on to a different area. I am sorry that this is still happening, but the number of times it has occurred is reducing.
- 5. FRC Court Users Meeting can I suggest we have a meeting on Teams on 15th November 2022 at 4.30. Invites to follow. <u>The link to join is here</u>.
- 6. Please feel free to email me in relation to any issues and to raise any points that you would wish to discuss at the meeting on 15th November.

COUNCIL MEMBER'S REPORT

I attended my first Council meeting as the Sussex representative at the Law Society on 12th October 2022. Over the years I have had cause to attend various meetings at the Law Society, mostly in my

role as a Criminal Law Solicitors Association committee member and mostly to do with Criminal Law, Legal Aid or Mental Health Law. I had not been since before the pandemic and am conscious that some Solicitors go through most or all of their career without visiting Chancery Lane, or at least not since an admission ceremony. That is a shame since it is your Society, you pay for the building and the facilities are very pleasant, a peaceful library and nice dining area. If visiting London, I'd recommend a visit. The Council meeting was in the elegant Reading room. The meeting was fairly formal and expertly chaired by the President I Stephanie Boyce. I liked the Countdown clock that limited contributions from the floor to 3 minutes. I've been on a few committees where that would have been useful, though not, of course the Sussex Law Society where contributions are always succinct and on point. I may suggest they add in the Countdown music for the last few seconds.

It was the last meeting for some on Council, there is now a 12-year limit and some fond farewells. It was also the formal transfer of office holders. The outgoing President, first black President and only the 6th female President, put the chain of office around the neck of the new president, the first Muslim President and 7th female. The new President passed her old chain on to the new Vice President and the new Vice passed his chain to the new Deputy Vice President. The music stopped with the DVP but to his disappointment he didn't appear to have a parcel to unwrap. There were some genuinely moving speeches from all concerned and we look forward to a constructive year with Lubna Shuja as our new President.

As for the formal business of the Council, I can summarise as follows and if anyone wants more details there is a paper that I can email out.

- 1.1 The President sent a letter expressing condolence and loyalty to His Majesty the King.
- 1.2 Criminal Legal Aid Criminal Legal Aid had been a continuing focus. The Society's campaign to secure the full implementation of the Bellamy review would be ongoing. This is essential to secure the future of a viable publicly funded service.
- 1.3 Solicitors Indemnity Fund The SRA had launched (on 6th October) a consultation on the rules and regulations for a future indemnity scheme: SRA | Consumer protection for post six-year negligence | Solicitors Regulation Authority. I. Stephanie Boyce reported to Council she was optimistic that by continuing to work cooperatively with the SRA, the Society would achieve a positive outcome that will protect both consumers and our members.
- 1.4 Diversity Framework

The outgoing President also highlighted to Council on 12 October that the Law Society has launched a new framework, which serves as a roadmap for workplaces to develop and deliver a strategic approach to Diversity and Inclusion (D&I): https://www.lawsociety.org.uk/topics/diversity - Use of the framework will help firms to establish purpose, develop a plan and ensure performance in their D&I activity.
