# SUMMARY OF CONCERNS RELATING TO DELAYS WITHIN HMCTS FOLLOWING CONSULTATION WITH MEMBERS

The Sussex Law Society with the assistance of its members has put together a short summary of concerns relating to the delays within the court system. This highlights the issues that have been raised by members. This information has been sent to a number of MPs. If you wish to use the following information to forward to your MP, please do not hesitate to do so.

Over a number of years we have been experiencing a significant decline in the efficiency of the court service which has had an impact on clients and other court users. The Sussex Law Society invited members to write in with the concerns that they had experienced with the courts and the impact that this was having. In summary, the common concerns are.

- 1. <u>Awaiting court hearings dates</u>. This is often taking many months.
- 2. <u>Delays in applications being processed</u> within financial proceedings/Children Act proceedings and civil cases.
- 3. <u>Taking cases out of the list just before hearing</u>. There have been numerous cases where the Court has contacted the instructed solicitors even sometimes just the day before the hearing to inform them that owing to a lack of judicial availability, the matter had to be adjourned.

The clients incur Counsel's fees. The usual terms and conditions are that if Counsel is cancelled two weeks to one week before the hearing, 50% of the fee is payable and up to one week before the hearing, a full fee is payable. This causes financial loss in terms of Counsel's fees, additional costs for delayed hearing preparation i.e. updated disclosure, delay in people being able to get on with their lives, frustration and emotional distress. In respect of applications for people to see their children, this delays contact between a child and a parent.

- 4. <u>Difficulties in communications with the Court.</u>
- 5. <u>Inexperienced administrative staff and documents not being made available to Judge</u>.
- 6. <u>Being encouraged by the Court to have private hearing i.e., Financial Dispute Resolution</u> <u>Hearings</u>. The parties pay a Private FDR Judge. The cost is on average £3,000 to £5,000 plus VAT to preside over a hearing to avoid delay in the court system.

A survey of Resolution (Family) Members found:

- (i) 20% said court delays caused client to rely on benefits.
- (ii) 34% said they had referred a client to a counsellor or therapist to help them cope with the stress of ongoing court delays.
- (iii) 90% said the court backlogs were causing additional and unnecessary stress and pressure for clients.

# THE CHASELEY TRUST – INVITATION TO JOIN THE BOARD OF TRUSTEES

Chaseley is a highly specialist Care Home situated on the seafront at Eastbourne in beautiful surroundings. Its Residents all have Acquired Brain Injury, whether it is through strokes, accidents or diseases such as Multiple Sclerosis. Nearly of them are in wheelchairs; some are unable to leave their beds. Nursing is central to the care they receive, plus individual attention from the Care Workers. Chaseley also has a very good Well Being and Activities department that provides enjoyment and diversions for the Residents. Every Resident is seen and treated as an individual. There are 55 Residents.

The Trustees would be very interested in recruiting someone with a legal background to join them. Experience in Social Care is not essential but would be very useful. So would HR. The Board does not wish to define exactly the experience that legal professionals could bring, but would be happy to hear from someone who feels they could contribute something of value and would have interest in the life of Chaseley. Good, all-round judgement is also desirable, as complex matters often arise, particularly at the moment when the whole area of Social Care is under great pressure.

The Board meets four times a year, at Chaseley, and during working hours. Meetings run for roughly 2 hours. For the rest of the time, Trustees communicate by email and occasionally by Zoom. Trustees can expect to be consulted from time to time about something that needs attention and for which they have relevant expertise.

The Trustees are all volunteers, but agreed expenses can be paid. The current Trustees are all experienced professionals – some retired, one still working. Our current strengths are in finance, marketing and general management. The CEO of Chaseley is dynamic and hardworking and enjoys good relations with the Board. The Board delegates all management functions to her but is ultimately responsible for financial and legal areas.

#### **COUNCIL MEMBER'S REPORT**

There has been no Law Society Council Meeting since the last Newsletter. The next is 12<sup>th</sup> December which I shall report upon in the January Newsletter.

Many of you will be aware that the Government has issued a further response to the Criminal Legal Aid Independent Review (Clair) which was commissioned by the Government and presented by Lord Bellamy KC in November 2021. Lord Bellamy said a minimum 15% increase in defence legal aid fees was needed <u>urgently</u> to ensure their viability. The Government initially came up with proposals worth just 9% for Solicitors. The recent report has said this will increase to 11%, but with no time scale. This is in the face of no increase in defence legal aid fees since 2001, and an 8.75% reduction in 2014. The Deputy Vice President of the Law Society (and next but one President) is Richard Atkinson, a well-known Criminal Lawyer from Kent who is a Partner at Tuckers Solicitors. He, the President, Lubna Shuja, and Head of Justice at the Law Society, Richard Miller, have been excoriating in their criticism of the Government's failure to implement the Bellamy Review. An example is their release of 30<sup>th</sup> November: <u>Real-terms cut to legal aid leaves no viable future for criminal defence |</u> <u>The Law Society</u> that summarises the position. Duty Solicitor provision is now very sparse in some areas in the country and declining everywhere. If there is no solicitor available when the Police want to carry out an interview, then they cannot progress the case. That may have an adverse impact on the suspect, the Police, witnesses and victims. Suspects may have to be released without interview.

Justice delayed is justice denied - for all parties. This should concern anyone who cares for access to justice and the rule of law.

Top of the list of all those being seen by the profession to be attacking it unjustifiably and in a heavy handed and disproportionate way is the SRA as it flexes its growing punitive muscles. Followed then by consumer lobbies urging a scientifically maximum degree of "transparency", an over-arching Legal Services Board which whilst providing inadequate funding expects increasing competence standards, instant improvement to its own embarrassing complaints service and a Government which is about to squeeze us even further on Compliance.

It is perhaps no surprise that an increasing number of members of the designated front line legal regulators are beginning to begrudge these impositions and develop an appetite for an alternative or even a return to self-regulation.

If you are looking for a white for your turkey Dominic suggests that Waitrose Blueprint White Burgundy 2020 is delicious at £10-99.

He recommends a few reds, Waitrose Primitivo by Terre di Faiano at £9.99 being his pick. Sainsburys and others sell a delicious Rioja, Beronia Reserva 2017/8 at £15 if you want a stunner. Beaujolais comes in many guises, ranging from the simple up to the named crus. Brouilly is widely available and is elegant, not heavy or rich. Château Thivin at about £20 is the very best and can be found at Fortnums and Harvey Nichols. Aldi and Lidl offer great value. Aldi has recently been selling a gorgeous Tasmanian Pinot Noir for £9-99 which would retail elsewhere for double. Lidl currently stocks 2019 Chianti at an absurd £5-99! Tesco own label Cotes Du Rhone is a fiver whilst it also stocks a serious version by Chapoutier (note the braille label) for £10. Waitrose has at £4-99 a range of own label wines with the Spanish red being outstanding.

If you want to celebrate with some fizz, Vintage Cava is widely available and is much better than Prosecco. Sparkling French Limoux at Aldi is £9. If only Champagne will do, then Tesco Finest is splendid. If it must be a name, let it be Piper Heidsieck which is on the shelf at £36 but regularly features on promotion, particularly at Sainsburys, where recently it came down to £19 on a buy 6 of anything promotion. Those who are flush will not go wrong with Charles Heidsieck at around £54.
