### **COUNCIL MEMBER'S REPORT**

On 10<sup>th</sup> May 2023 there was a Law Society Council Meeting and I attended this as the Sussex constituency representative. This was a meeting on Teams only, so no trip to the Big Smoke. Council business is split into Part 1 – business that can be reported back to constituents and Part 2 – confidential matters where the detail cannot be reported.

Part 1 business consisted of the President's oral report. Lubna Shuja is a most impressive President and also a very busy one, representing the Law Society in Japan and Korea in the last few weeks. You should all be aware that the Law Society has issued Climate Change Guidance for Solicitors. The stated aim is to pre-empt the climate change risk your organization faces and do business competently and compliantly. Other matters dealt with at the meeting included:

- The President has had an introductory meeting with the (latest) Lord Chancellor, Alex Chalk
- The Criminal Fees JR awaits a decision on permission from the High Court. If any Criminal Lawyer would like to submit a witness statement on the impact of the failure to increase fees over the last 20 years on their practice and the inadequacy of the 9% increase then contact me and I can direct you to those co ordinating evidence.
- The review continues on the application by CILEX to be regulated by the SRA rather than their present regulator. Your practicing fee pays for the SRA and so the Law Society has an interest in this.
- TLS is working on a "21<sup>st</sup> Century Justice" project looking at how the organisation can shape
  the future of the Civil and Criminal Justice systems moving forward. Further information can

#### **COMPLIANCE AND REGULATORY AFFAIRS SUB-COMMITTEE**

Solicitors' practising fees are set to increase substantially this year " is the headline news in the legal press. Should you be interested to know how your annual PC fee is assessed and distributed, or even how this proposal may be put to the LSB (the overarching statutory Regulator of various legal services) for approval and how they would sit with the current yearly strategic budgets of TLS and the SRA respectively, please refer to the two brief SRA Consultation papers on the SRA website here.

Of lesser interest, except to those Solicitors who represent claimants relating to financial products and services, is the current Consultation on draft Rules to protect consumers from excessive charges.

Monthly figures and anecdotal evidence emanating from the Board of LeO suggest that by February 2024 the long backlog in complaint handling will have been absorbed together with a degree of confidence that a more even keel will be restored by year end 1st April. Staff retention, sickness and inexperience, particularly at pre-assessment level, were given as explanations for very poor performance levels. In addition to a salvage package last year, there appears a substantial hike in the annual budget just lodged with the LSB for approval. With the recent roll-out of the new 6-month scheme Rule, a commitment to training at the pre-assessment stage, increased staff recruitment both at HQ in Birmingham and now a small new hub office in Leeds, there is a will and confidence that these targets will be achieved.

## PLEASE SUPPORT THE PRESIDENT'S CHARITY

This year the President has chosen to support <u>The Clocktower Sanctuary</u> as his charity and we are hoping to raise as much as we can at the Society's Summer Masquerade Ball on 16<sup>th</sup> June. If you are not coming to the Ball please consider supporting this amazing charity which is the only drop-in day centre for homeless 16-to-25-year-olds in Brighton. It is a place where young people who have nowhere to call home can feel safe and 'just be'. They listen and respond to what they need and treat everyone as an individual. They know that no young person chooses to be homeless.

Last year, they had **2,912 visits from young people who had nowhere to call home.** The charity has shared this story with us about one young man called Joe:

As a teenager Joe lived in London. He struggled with bipolar disorder and the mood swings it caused meant his family relationships broke down. Being young and vulnerable he was a target for drug dealers and developed an addiction. He got clean, got treatment for his mental health and moved to Brighton for a fresh start. But he was relying on friends for a place to stay at night which made it hard to find a job. That's when he found The Clock Tower Sanctuary. When Joe first came to The Clock Tower Sanctuary, we could see how motivated he was to get his life back on track. We helped him get in touch with the local mental health team and addiction services to support his on-going recovery. We also supported him with registering for benefits and finding out about his housing options. His confidence grew and told us about his dreams of being a hairdresser. We found a local salon who gave him a trial, and it turned out he was a natural. The salon manager said "I was worried at the start, but it has been a positive experience. Joe is quirky respectful, polite - everyone likes him. We are delighted." Joe started an apprenticeship and a part-time college course in

hairdressing. With increased confidence and money he could get a place of his own to stay. He says: "It's because of The Clock Tower Sanctuary that I could enrol in the course. I was able to build up my CV and use the phone. I feel like I have stability and control to reach my goals for the first time."

#### WHAT DO LAWYERS THINK OF THE LAY MAGISTRACY?

Dr Lucy Welsh at Sussex University is preparing a research project on what lawyers' think of the lay magistracy. They are hoping to hold four focus groups: two with defence lawyers and two with prosecutors. The sessions would last about 90 minutes each at Sussex, with no more than 8 participants (exclusively either defence lawyers or prosecutors) in each group and refreshments provided/expenses paid. The participants will obviously be known to each other, but they would ask the group members to keep the conversations confidential, and they would anonymise the data and avoid including information that could lead to identification.

They hope to develop this is a couple of ways. First, to publish some of this data in an academic journal, and second as part of a wider project looking at the perceived legitimacy of the lay magistracy.
