## LAA DATA HACK

Legal Aid Practitioners continue to experience problems with the Legal Aid Agency Online system currently being offline. At the time of writing there is no date for this coming back online and this will be causing both Solicitors and clients some problems.

One concern expressed was whether firms need to inform past and present clients of the data breach. The LAA has taken ownership of this as below:

### Do legal aid providers need to contact clients?

There is no contractual obligation on providers to report this incident to the ICO or to inform clients. The data impacted by this incident is either owned by the LAA or is considered Shared Data within the definition of the contract. The contract at clause 16.3 of the standard terms sets out that the responsibilities of the data controller will be exercised by the party in possession of the data – in this case by MoJ as the data controller for LAA. MoJ has notified the ICO of the incident, and has notified data subjects through the public announcement on GOV.UK on 19 May.

### COMPLIANCE AND REGULATORY AFFAIRS

Fresh guidance, its second under LeO's recent “spotlights” series has been issued. With nearly a half of Complaints currently about poor communication and delay, it highlights with the aid of case studies the common and much debated topical feature of delay where the service provider may be deemed responsible for, or could have influenced a delay caused by a third party or an event outside their control. One obviously thinks of legal matters which involve The Land Registry, Probate, Court, Home Office, expert and other professional Reports. What are deemed to be “reasonable” (sigh) steps which LeO seems to expect? Effective communication throughout might save you time, the fee and the Client. The key seems to be managing expectation from the outset and sharing information and measures being taken on progress throughout. Failure could influence the Decision. ## COUNCIL MEMBER'S REPORT

There was a special council meeting on 7th May at Chancery lane consisting of a special session on the rule of law and hustings involving 5 candidates to be the next deputy vice president of the Law Society. The DVP is elected by the 97 Council members and I cast a vote on behalf of Sussex.

DVP election: The result was announced last Friday and Dana Dennis-Smith, OBE, has been elected as the new DVP. She will become President in 2027. Dana holds one of 5 seats representing women solicitors on Council. She founded the First 100 Years campaign to celebrate 100 years of women solicitors and received her OBE for services to women in the law. I look forward to supporting her and the other officers in the coming years. Rule of law: The Law Society sees as one of its most important functions the protection of the Rule of Law in England and Wales and abroad. Important enough to devote a Council meeting to the topic to help guide its thinking in coming years. The meeting involved presentations and breakout sessions looking at what the Rule of Law means both nationally and internationally, threats to it and how TLS can continue to promote understanding of it. I have always found "Rule of Law" a tricky phrase to understand. At first blush it seems tautologous. The words Rule and Law can mean almost the same thing.

In (Lord) Tom Bingham's book entitled The Rule of Law he says "...the expression was constantly on people's lips [but] I was not quite sure what it meant, and I was not sure that all those who used the expression knew what they meant either, or meant the same thing." At a breakout session on 7<sup>th</sup> May I expressed my concern that this widely used phrase was not well understood. The proverbial "person on the Clapham omnibus" might regard the rule of law as having to stick to the speed limit or not stealing from Sainsbury's (other supermarkets are available). This may in part be accurate but cannot be the whole concept.

Dicey formulated the Rule of Law as:

1. Supremacy of regular law (the Clapham Omnibus understanding, that is you are subject to known laws and punishments, not the arbitrary use of power)
2. Equality before the law – yes you too, Boris.
3. Constitutional principles arise from judicial decisions – the power of case law within our unwritten constitution. The post Dicey case of *Associated Provincial Picture Houses v Wednesbury Corporation, 1948*, laid the ground for the recent evolution of Judicial Review. This case law based doctrine has become an important check on executive power.

Since the 1940s the Rule of Law has also taken on an International dimension with Human Rights obligations.

On 7<sup>th</sup> May I spoke with one of the international team at TLS who told me of visits she had made to imprisoned lawyers in Turkey. TLS has mounted a campaign advocating for their release. They are imprisoned for doing their job as lawyers in a way the Government doesn't like. This is a tactic designed to suppress the rule of law. As Shakespeare says (though in a different context), "First let's kill all the lawyers", or at least imprison them. Bill Browder's book *Red Notice* is an example of a state, Russia, killing a lawyer for political purposes.

So, whilst we may find the principle difficult to define we know it when we see it, as I hope three contemporary examples illustrate:

1. In September 2019, a slight, grey haired woman, wearing a distinctive spider brooch (Lady Hale) gave the judgment of the Supreme Court that ruled that Boris Johnson's decision to prorogue Parliament in September of that year was unlawful. Law 1, PM 0.
2. On 29<sup>th</sup> May 2025 a trade court in the US blocked some US tariffs, on the basis that they should not have fallen within an executive order signed by the President. That battle is headed for the Supreme Court that will give Judgment on the scope of those powers. As an aside, it seems to me that the US separation of powers is weakened because Supreme Court Judges are themselves political appointees – mitigated, perhaps, by the slow turnover.
3. Finally, Vladimir Putin's Russia. A state where there is no Rule of Law.

Thank you if you have got this far. This short piece only scratches the surface of the topic but I hope shows why the concept is so important to The Law Society.
